OUR MANUFACTURING CAPACITY

On account of an astronomical manufacturing capacity, accretion is capable of manufacturing variegated medicines and wellness products with top-notch quality within stipulated timelines.



Tablets

With 2 automatic granulation lines and 5 high speed rotary tablet compression lines with bi-layered attachment in place, we are capable of manufacturing 150 million tablets per month inclusive of packing and distribution. What more? We have 3 coating units and 6 packing lines in place to ensure speedy and quality manufacturing. Our packing lines includes blister, ALU-ALU foil and strips.

Capsules

At accretion, we have fully automated capsule filling machine ct-70, which enable us to have formulation of hard dry capsule without human contact. The automated process helps us in speedy polishing and sorting. We have facility to encapsulate powder as well as pellets in gelatine based / HPMC based (vegetarian) capsule. We also have extra semi-automated line for capsule filling. Total output for capsule section is around 50 million per month.



Oral liquids

We are a preeminent oral liquid manufacturing company capable of manufacturing 2 million bottles of oral liquids every month which includes both packing and distribution. Within 500, 1000 and 2000 litres of fully automated manufacturing plants is place, we can manufacture syrup, suspension and solution of variable batch sizes.

External preparations

We are having 500kg fully automated manufacturing plant for external preparations such as cream, gel, lotion, ointment and medicated shampoo. We have state-of-art linear filling line for tubes and jars with capacity of 1 million tubes in a month. Other than semi-solid form, we are also providing dusting powder and mouthwash in external preparations.

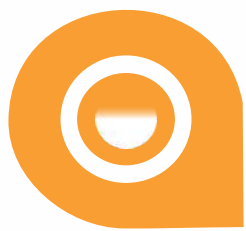
